# F-1 FIREARMS

## 2018 Authorized Dealer Requirements and Brand Policies

### STANDARD CONDITIONS

- All orders, special programs and/or terms are only valid if written and accepted by F-1 Firearms.
- Pricing, terms and other programs may change without notice but all attempts are made to limit program changes to two times per year (usually around January and July) with advanced written notice.
- Shipments are sent from our Spring, Texas warehouse, billed to the customer, or the customer's freight account is billed. UPS is the default shipping vendor.
- Orders are billed and charged the day of shipment. Credit card must be on file at all times.
- Standard rifle build order turn around time is 45 days or less from receipt of purchase order.

### AUTHORIZED DEALER REQUIREMENTS

- Approved dealer application, export compliance, policy compliance and maintaining current balance are required to be an Authorized Dealer.
- Authorized F-1 Firearms Dealer \_\_\_\_\_: requires \$5,000 of purchases in F-1 Firearms product and a minimum initial order of \$2,500. Account status is subject to review every six (6) months.
- Master F-1 Firearms Dealer \_\_\_\_\_: requires \$40,000 of purchases in F-1 Firearms product and a minimum initial order of \$15,000. Account status is subject to review every six (6) months.
- If dealer requirements are not met within the allotted timeframe dealer will be charged 5% of all invoiced product.

### RETURN POLICY / DEFECTS

- Dealers will have (5) business days from the date product is received to notify F-1 Firearms of any objections such as damaged goods, discrepancy between the goods ordered and the goods delivered, or any other grounds for rejecting any shipment, in whole or in part.
- F-1 Firearms offers a 100% Product Guarantee (On F-1 Firearms products)
- Dealer defective returns are for credit or replacement and require a return authorization number (RA#), which will be given by F-1 Firearms Customer Service department.
- Dealers pay shipping on returned item(s).
- As an authorized dealer you can act on behalf of F-1 Firearms as the first level of warranty claims. F-1 Firearms expects each Authorized Dealer to use their best judgment on how to handle warranty claims prior to contacting F-1 Firearms' Customer Service department.

### MAP POLICY

- MAP (Minimum Advertised Price) is in place to ensure price integrity of products in the market.
- Special marketing campaigns or promotional activities below MAP pricing may be granted but for a short duration. These must include a direct marketing component and be approved in writing by F-1 Firearms (contact your representative for details).
- F-1 Firearms reserves the right to suspend or adjust a MAP policy for any product at any time.

### MERCHANDISING POLICY

- Dealers will be required to update product images, pricing, technical detail and other information within a reasonable time frame of notification by F-1 Firearms.
- Dealer employees who have been employed by Authorized Dealers or Master dealers longer than 6 months are eligible for an Employee Discount of 20% off of MSRP. This discount is not applicable on new products without prior written consent by F-1 Firearms and is limited to 1 rifle per employee per year.
- Establishment of stores, listings or distribution on third-party sites (i.e. Ebay, Amazon, or Gun Broker) without written permission is strictly forbidden.
- Customers should train their staff to be able to present F-1 Firearms products in a professional, honest and knowledgeable manner. Please contact representative group for materials and information.

### MERCHANDISING & MAP ENFORCEMENT POLICY

- F-1 Firearms may cease shipments for items that violate merchandising or MAP policies.
- Dealers who continually fail to follow policies in place may lose Authorized Dealer status and be banned from selling F-1 Firearms products.

### EXPORT LIMITATIONS AND OTHER LEGAL ISSUES ARE SUBJECT TO ITAR

- Establishment of distribution channels outside the United States without written permission is strictly forbidden.
- F-1 Firearms and its employees cannot offer legal advice. Each F-1 Firearms dealer is responsible for following foreign, federal, state and local laws. Please seek legal counsel for export, regulatory and all other legal issues.
